CALIFORNIA PRIVACY NOTICE

Last updated October 10, 2024

This California Consumer Privacy Act Notice ("California Notice") explains how Athlete To Athlete LLC ("we," "us," or "our"), manage your personal information, the reasons for doing so, and the rights you have as a California resident concerning your information. This Notice is an addition to the Athlete to Athlete Privacy Policy.

California Civil Code Section 1798.83, commonly referred to as the "Shine The Light" law, allows California residents to request and receive, once annually and at no cost, details about the categories of Personal Information (if any) we have shared with third parties for direct marketing purposes, as well as the names and addresses of those third parties. If you are a California resident and wish to make such a request, please email info@athletetoathlete.org.

If you are under 18, live in California, and have an active account with our Services, you have the right to request the removal of any unwanted data you have posted publicly. To request this removal, please email info@athletetoathlete.org, and include the email address linked to your account along with a statement confirming your California residence. We will ensure that the data is no longer publicly visible on our Services, but please note that it may not be entirely or fully removed from all of our systems (e.g., backups, etc.).

1. WHAT CATEGORIES OF PERSONAL INFORMATION DO WE COLLECT?

We have collected the following categories of personal information in the past twelve (12) months:

I. Professional or employment- related information	Business contact details in order to provide you our Services at a business level or job title, work history, and professional qualifications if you apply for a job with us	NO
J. Education Information	Student records and directory information	NO
K. Inferences drawn from collected personal information	Inferences drawn from any of the collected personal information listed above to create a profile or summary about, for example, an individual's preferences and characteristics	NO
L. Sensitive personal Information	Debit or credit card numbers	YES

We will use and retain the collected personal information as needed to provide the Services or for:

- Category A As long as the user has an account with us
- Category B As long as the user has an account with us
- Category C As long as the user has an account with us
- Category L As long as the user has an account with us

Category L information may be used, or disclosed to a service provider or contractor, for additional, specified purposes. You have the right to limit the use or disclosure of your sensitive personal information.

We may also collect other personal information outside of these categories through instances where you interact with us in person, online, or by phone or mail in the context of:

- Receiving help through our customer support channels;
- Participation in marketing efforts, customer surveys or contests; and

• Facilitation in the delivery of our Services and to respond to your inquiries.

2. RIGHT TO CORRECT YOUR DATA

You have the right to request that we correct any inaccurate personal information we hold about you. To verify the accuracy of the information, we may ask you for supporting documentation. Any documentation you provide, whether requested by us or submitted voluntarily, will be used solely for correcting your personal information and for complying with recordkeeping requirements under the CCPA and/or CPRA.

Alternatively, we may choose to delete the inaccurate Personal Information if it does not adversely affect you or if you agree to its deletion, subject to certain exceptions provided by law.

3. RIGHT TO REQUEST DELETION OF THE DATA

You can ask for the deletion of your Personal Information. If you ask us to delete your Personal Information, we will respect your request and delete your Personal Information, subject to certain exceptions provided by law, such as (but not limited to) the exercise by another consumer of his or her right to free speech, our compliance requirements resulting from a legal obligation, or any processing that may be required to protect against illegal activities.

In accordance with applicable law, we are not obligated to provide or delete consumer information that is de-identified in response to a consumer request or to re-identify individual data to verify a consumer request.

4. RIGHT TO OPT-OUT OF THIRD-PARTY SHARING OF YOUR PERSONAL INFORMATION

You may request to opt out from future selling or sharing of your Personal Information to third parties. Upon receiving an opt-out request, we will act upon the request as soon as feasibly possible, but no later than fifteen (15) days from the date of your request.

5. RIGHT TO BE INFORMED

Depending on the circumstances, you have a right to know:

- whether we collect and use your Personal Information;
- the categories of Personal Information that we collect;
- the purposes for which the collected Personal Information is used:
- whether we sell or share Personal Information to third parties;
- the categories of Personal Information that we sold, shared, or disclosed for a business purpose;
- the categories of third parties to whom the Personal Information was sold, shared, or disclosed for a business purpose;
- the business or commercial purpose for collecting, selling, or sharing Personal Information: and
- the specific pieces of Personal Information we collected about you.

6. Right To Limit Use And Disclosure Of Sensitive Personal Information

You have the right to direct that we to limit its use of your sensitive Personal Information to that use which is necessary to perform the Services.

Once we receive your request, we are no longer allowed to use or disclose your sensitive Personal Information for any other purpose unless you provide consent for the use or disclosure of sensitive Personal Information for additional purposes.

Please note that sensitive Personal Information that is collected or processed without the purpose of inferring characteristics about a consumer is not covered by this right, as well as the publicly available information.

7. AUTHORIZED AGENT

You may choose a person registered with the California Secretary of State that you authorize to act on your behalf to submit your we require that you provide the Authorized Agent with written permission to allow them to submit your request and that you verify your identity directly with us. Failure to do so may result in us denying your request.

An Authorized Agent may e-mail proof of signed permission along with a copy of their identification and have you directly confirm with us that they provided permission to submit the request on your behalf, by sending an e-mail to info@athleteoathlete.org.

8. VERIFICATION PROCESS

Upon receiving your request, we will need to verify your identity to determine you are the same person about whom we have the information in our system. These verification efforts require us to ask you to provide information so that we can match it with information you have previously provided us. For instance, depending on the type of request you submit, we may ask you to provide certain information so that we can match the information you provide with the information we already have on file, or we may contact you through a communication method (e.g., phone or email) that you have previously provided to us. We may also use other verification methods as the circumstances dictate.

We will only use Personal Information provided in your request to verify your identity or authority to make the request. To the extent possible, we will avoid requesting additional information from you for the purposes of verification. However, if we cannot verify your identity from the information already maintained by us, we may request that you provide additional information for the purposes of verifying your identity and for security or fraud-prevention purposes. We will delete such additionally provided information as soon as we finish verifying you.

9. Right to Non-Discrimination for the Exercise of a Consumer's Privacy Rights

We will not discriminate against you if you exercise your privacy rights.
